The Province Forest Directorate, Province no 1 invites sealed and or electronic bids from eligible bidders for the procurement of Procurement of Forest Measurement Instrument (Global positioning system (GPS) & Height measurement instrument (Laser Range Finder) under National Competitive Bidding procedures specified in Public Procurement Act and Regulations.

Evaluation will be done slice by slice basis, with contracts awarded based on the award combination that is of least cost to the Purchaser.]

3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Province Forest Directorate, Koshi Province, Dharan, Sunsari. Nepal or may visit PPMO epg system website www.bolpatra.gov.np/egp.

If hardcopy is allowed then a complete set of Bidding Documents may be purchased from the office Forest Directorate, Koshi Province, Dharan, Sunsari ,Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs 3000.0 till 23-04-2024 14:00 during office hours.

OR

A complete set of Bidding Documents may be purchased from the following bank/office by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 3000.0 NRs till 23-04-2024 14:00. If so requested Bidding Documents can also be sent by post/ service upon payment of additional fee for post/courier. However the Employer will not be responsible for delay or non-delivery of the document to sent

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2024-2024 12:00 hours at the office of Forest Directorate, Koshi Province, Dharam, Sunsari Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 142500.0NRs which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
